Unit Overview

This comprehensive 5-day training course is designed to equip participants with the required skills and knowledge to perform dogging work in accordance with national licensing requirements. Dogging involves slinging loads, selecting and inspecting lifting gear, and directing crane operators when the load is out of their direct line of sight.

The course is aligned with the National Standard for Licensing Persons Performing High Risk Work, ensuring all participants are prepared to undertake dogging tasks in a variety of high-risk environments safely and competently.

Training is delivered through a combination of theory, practical demonstrations, and hands-on learning, with a strong emphasis on workplace safety, hazard management, and load movement control.

This course is ideal for individuals working in or intending to work in:

- Construction
- Mining
- Civil Infrastructure
- Transport and Logistics
- Heavy Industry or Plant Operations

Completion of this course is a requirement for those needing a **High Risk Work Licence (class DG)** to legally perform dogging duties on Australian worksites.

Entry Requirements

- Be **18 years of age or older**
- Possess or obtain a **USI (Unique Student Identifier)** – [Apply here](#) if you do not have one
- Provide **three (3) valid forms of identification** (refer to final page for acceptable ID types)
- Wear **closed-in footwear** and a **high visibility (hi-vis) shirt**
- Successfully complete an **LLN (Language, Literacy & Numeracy) assessment** to identify any required support

Pre-requisites: None

Learning Outcomes

- Communication techniques in the workplace including whistles, hand signals and use of fixed channel two-way radios
- Calculate rated capacity of lifting equipment
- Ability to interpret rated capacity and working load limit tags
- Hazard identification and control
- Sliding techniques
- Selection and inspection of lifting equipment
- Directing crane operators in the moving of loads in a safe manner, using a slewing crane
- Inspection and care of a wide range of lifting equipment to appropriate Australian Standards and/or manufacturer's specifications
- Appropriate mathematical procedures for estimation and measurement of loads
- Basic knowledge of types of cranes and their functions
- WHS legislation, standards and codes of practice relevant to the full range of techniques for undertaking dogging activities
- Load stability and safety factors in line with manufacturer's specifications
- Understanding of the hierarchy of control

Performance Criteria

Participants will be trained and assessed in the following key competency areas:

- **Plan the job** – including risk assessments and consultation
- **Select and inspect equipment** – ensure compliance with safety standards
- **Prepare site and equipment** – establish safe work zones and gear readiness
- **Perform dogging tasks** – sling loads and direct crane operators
- **Shutdown and clean-up** – complete job safely and return equipment to service

Certification & Licensing

Upon successful completion of all course requirements, participants will receive a **Statement of Attainment** for:

CPCCLDG3001 – Licence to Perform Dogging

This nationally recognised certification forms the basis of an application for a **High Risk Work Licence (class DG)** through your state or territory regulator (e.g., WorkSafe, WHSQ).

Important:

While your **Statement of Attainment does not expire**, your **High Risk Work Licence must be renewed every 5 years**. You are **not legally permitted to perform dogging work** if your licence is expired.

Evidence of Identity

At least one category A document must be photographic and show a full name and date of birth (DOB)

A candidate must produce, and an assessor must sight, three matching, original, evidence of identity (EOI) documents before undertaking an assessment or reassessment.

The EOI documents must comprise either:

- One (1) Category A document and two (2) Category B documents, or
- Two (2) Category A documents and one (1) Category B document.
- The category A document must show your full name and date of birth. **Certified photocopies will not be accepted.**
- All documents must be current unless otherwise stated.
- At least one Category A document must be photographic and show a candidate's full name.
- At least one Category A or B document must show the candidate's signature and date of birth.
