Course Description

Training is conducted in a variety of workplace settings, such as:

- Agricultural properties
- Forest operations
- Workshops
- Arboretums and horticultural environments

Course Description

Level 2 builds on the foundational skills developed in Level 1. It covers the safe **manual felling of small trees** with low complexity. The course includes:

- Pre-felling hazard assessment
- Planning fall direction
- Safe cutting techniques
- Use of wedges and safety gear
- Chainsaw operation and maintenance during felling

This unit applies to non-production forestry and land management operations.

Entry Requirements

- Must have successfully completed **Chainsaw Level One**
- Minimum age: **16 years**
- Valid **USI**
- **Three (3) forms of ID**
- **Closed-in footwear**

Evidence of Identity

At least one category A document must be photographic and show a full name and date of birth (DOB)

A candidate must produce, and an assessor must sight, three matching, original, evidence of identity (EOI) documents before undertaking an assessment or reassessment.

The EOI documents must comprise either:

- One (1) Category A document and two (2) Category B documents, or
- Two (2) Category A documents and one (1) Category B document.
- The category A document must show your full name and date of birth. **Certified photocopies will not be accepted.**
- All documents must be current unless otherwise stated.
- At least one Category A document must be photographic and show a candidate's full name.
- At least one Category A or B document must show the candidate's signature and date of birth.
